

**TEXAS TECH UNIVERSITY SOUTHWEST COLLECTION SPECIAL
COLLECTIONS LIBRARY (SWC/SCL)
AUDIOVISUAL DUPLICATION REQUEST FORM**

The SWC/SCL will consider duplication requests for audiovisual material (oral history, sound recordings, or moving image) under the following stipulations: original material will not be damaged during digitization, no copyright infringement will occur, donor agreement allows for duplication, patron will not alter the material, there can be no posting of SWC/SCL materials to websites outside of the Texas Tech University system, and audiovisual material used must include required SCW/SCL citation and attribution. All duplicated items will be delivered on either CD or DVD optical media, unless special arrangements are made in advance for another format.

The transfer of archival audiovisual material takes a considerable amount of time. Please allow enough time for the SWC staff to complete your requests. Depending on the material, a request may take several weeks to complete. In most cases, the materials delivered will be full transfers of original items as they are. No extraordinary enhancements, editing, or clipping will be made.

EXAMPLE CITATION REQUIRED FOR SWC/SCL AUDIOVISUAL MATERIALS:

COSTS

\$25.00 per Audio CD (one CD holds up to 80 minutes of audio)

\$35.00 per Moving Image DVD (one DVD holds approximately two hours of video)

Applicable shipping and processing fees

Commercial use fee

Taxes (8.25%)

COMMERCIAL USE FEES

For-profit commercial ventures require a \$20.00 commercial use fee per item. The commercial use fee will allow the patron a one-time use of the audiovisual item.

The patron assumes full responsibility for conforming to all copyright laws and for securing permission to use the audiovisual materials from the copyright holder. If audiovisual material is used in a broadcast, documentary, or similar resulting program, the SWC/SCL may request a copy of the end product.

The SWC/SCL waives the commercial use fee for students and scholarly researchers engaged in a not-for-profit activity. However, the one-time use restriction of the audiovisual material and all applicable copyright laws remain in effect.

ORAL HISTORY RESTRICTIONS

Oral history duplication is limited to family members only. You must specify your relationship to the interviewee in order to obtain an audio copy of the interview. If you are not related to an interviewee, SWC/SCL staff members will check the release status of the interview. Typically there are two options: 1) Researchers can contact interviewee and/or descendents to request written permission for duplication. 2) Interviews with releases can be requested to be transcribed and placed on our dspace website. The fulfillment of Texas Tech game film requests is contingent upon patrons divulging their affiliation to the University, the physical condition of the recordings, and existing copyright restrictions. Requests may be completed by the Athletics department. The SWC/SCL has the right to restrict the number of films digitized as well as the right to turn down any film request due to deteriorating physical condition of the film and/or copyright restrictions. Because of the fragile media and wear/tear on our equipment, game film is duplicated one game per DVD.
